## HMRC Goods Vehicle Movement Service (GVMS) – Haulier communications to support GVMS Release 2.2 Imports

### Audience

These communications have been produced to make hauliers aware of the new rules that apply from Midnight 31 December 2021 Greenwich Mean Time (GMT) when moving goods between Great Britain (GB) and the European Union (EU)\* [through border locations that have adopted GVMS](#)

### Key Summary:

- Staged Customs Controls end from Midnight 31 December 2021 GMT\*
- GVMS will go-live for all movements from EU>GB\* from Midnight GMT 31 December 2021
- If moving goods through border locations that have adopted GVMS you must provide a Goods Movement Reference (GMR) for all crossings departing from midnight 31 December 2021 GMT\*
- If you do not provide a valid GMR you will be turned away from the border location and will not be able to board the ferry or shuttle
- Hauliers can start to create GMR's for the movements above from 15 December 2021 in advance of the go-live date Midnight 31 December 2021 GMT

\*The above is with the exception of direct movements between Ireland and GB. Staged Customs Controls will continue to apply from Ireland to GB until further notice

### Goods Vehicle Movement Service Release 2.2

For movements between EU and GB, GVMS is currently only used for Common Transit Convention (CTC) movements in one direction (EU>GB).

However from midnight 31 December 2021 GMT and onwards, all goods being imported into GB\* at [border locations](#) that have adopted GVMS must be accompanied by a valid GMR. This means that if you try to check in from midnight 31 December 2021 GMT and onwards without a valid GMR, then you will be not be allowed to board the ferry or shuttle.

Any movements which are due to check in before midnight GMT a GMR will not be required, even if the goods will arrive in the UK after midnight.

\*The above is with the exception of direct movements between Ireland and GB. Staged Customs Controls will continue to apply from Ireland to GB until further notice

## Who needs to register and create GMRs?

The Haulier moving the goods is responsible for registering for GVMS and creating a GMR, but that can be passed to a 3rd party such as an agent or other intermediary.

A haulier may be defined as:

- an independent driver transporting goods and doing your own customs paperwork
- a company that sub-contracts to pick up goods on behalf of another business
- a logistics business, hired to transport goods and complete customs processes on behalf of another business
- a large retail business, that transports and declares your own goods

## Imports EU>GB and creating GMR's

### Using GVMS from 15 December 2021

To help businesses prepare early, you can submit pre-lodged declarations and create a GMR from 15 December 2021 for any movements on or after 1 January 2022. To do this:

1. Declarants should submit a pre-lodged, or arrived declaration on CHIEF using Additional Information code 'RRS01' (<https://www.gov.uk/government/publications/customs-declaration-completion-requirements-for-great-britain>)
2. Hauliers should create a GMR in Goods Vehicle Movement service (GVMS).

For goods moving from EU to GB\*, GVMS functionality will be available for use **from 15 December 2021** to accommodate all import movement types detailed in the table below.

This will allow hauliers to plan and create GMR's in advance of go live for EU to GB\* movements on midnight 31 December 2021GMT.

Please note that other than for CTC movements (already in scope) you should not use this functionality for any movements that take place before midnight 31 December 2021.

**\*The above is with the exception of direct movements between Ireland and GB. Staged Customs Controls will continue to apply from Ireland to GB until further notice**

Hauliers should enter the following information into their GMRs as follows:

| <b>Movement Type</b>  | <b>References to be entered into a GMR</b>  |

| Imports declared into Customs Handling of Import & Export Freight (CHIEF) or Customs Declaration Service (CDS)                              | 18 digit Entry Reference Number for CHIEF (ERN) or Movement Reference Number (MRN) entered into GMR                 |
| Entry in declarants records (EIDR) where authorised traders declares into their own records using Simplified Customs Declaration procedures | An authorised and valid GB EORI This will start with 'GB' followed by 12 or 15 numbers, for example GB123456789000. |
| ATA and TiR Carnet  | Carnet reference numbers from top right hand of carnet documents  |
| CTC Movements (already required so no change)   | 18 digit number Transit Accompanying Document (TAD) Movement Reference Number (MRN)                                 |

### Oral and conduct declarations

You must also complete a GMR if moving goods [and making declarations orally or under conduct](#) in this direction.

The oral/conduct option should be selected as appropriate when completing your GMR.

### Empty vehicles

Likewise you should enter details of empty vehicles into a GMR, this includes empty vehicles, trailers and containers (either 100% empty or which contain recyclable packaging).

The empty option should be selected as appropriate when completing your GMR.

### Postal Declarations

If you are a designated postal operator or Extra-Territorial Office of Exchange (ETOE) moving items of correspondence and goods under Universal Postal Union (UPU) terms (this includes goods with the following movement documents; CN37, CN38 and CN41, and the following item declaration forms; CN22 and CN23), then you will need to complete a GMR and select the 'Postal Declaration' option.

### Safety and Security Entry Summary Declarations (ENS)

Safety and Security Entry Summary Declarations are not legally required for EU>GB movements until 1 July 2022, but you can optionally enter these from 1 January 2022

## Customs Controls

When moving goods between EU and GB, drivers may need to report for either an inspection of their goods or further controls such as:

- Office of Destination procedures (for CTC movements)
- Movements of animals, plants or organics
- Goods covered by the Convention on International Trade in Endangered Species (CITES)

When importing goods from 1 January 2022, you must follow HMRC instructions about whether you need to get your goods checked on arrival.

You may be directed to an Inland Border Facility (IBF) for documentary or physical checks of your load if these controls cannot be done at the border. This currently applies for border locations at Dover, Eurotunnel terminal at Cheriton, and Holyhead.

Please note that in some cases you may also be stopped within the border location to have checks performed on your vehicle. If this happens, you must still attend an IBF if you have received instructions to do so. The goods must travel to an IBF directly and must arrive in the same condition as the goods were at the time of importation.

A driver can check the status of the goods themselves using the '[Check if you need to report for an inspection](#) service', as long as they have access to a device that can access the internet, such as a mobile phone. Please note that this service currently only provides details of customs checks so drivers must also check with the haulier and declarant if there are further checks required, such as CITES.

The person who created the Goods Movement Reference (GMR) (usually the haulier) should ensure that the goods arrive at an IBF for a check, and that their drivers are made aware or have the means to check if an inspection is required. The responsibility for passing any messages regarding checks to drivers lies with person who created the GMR.

From 1 January 2022, hauliers and/or drivers may be liable to a penalty of up to £2,500 if they fail to follow HMRC instructions. The haulier, as well as the driver, must follow HMRC instructions and take proportionate and reasonable steps to ensure that the goods arrive at an IBF.

It is important that you take steps to ensure that your supply chain is ready and understand how you intend to operate from January 2022.

## Business Continuity

We regularly manage updates to our IT systems to ensure they perform as expected and will always try to minimise disruption for businesses and individuals wherever possible. Business Continuity Planning (BCP) is an essential requirement to ensure goods can continue to move in the unlikely event of system downtime or technical issues. In the unlikely event of BCP being invoked we will communicate to key

groups affected including businesses representative bodies to make them aware of fall-back processes they need to implement

We continue to work with stakeholders to ensure they understand the steps they need to take to move goods through border locations in all scenarios.
